The Village of Milo may, after the public auction, become the owner of any parcel of land not sold at the public auction. Terms: Cash, certified cheque, E-transfer, bank draft or money order. GST will be added to all successful bids. A deposit of 10% of the successful bid payable in cash, certified cheque, E-transfer, bank draft or money order must be received by 2:00 p.m. on the day of the sale. The balance of the purchase price shall be paid on or before Tuesday of the week following the public auction. Redemption may be affected by payment of all arrears of taxes and costs at any time prior to the sale.
